

CHAPTER 11
TOWN OF DECATUR
ORDINANCE REGULATING SPEED LIMITS
ON TOWN ROADS

Section 1: WHEREAS the Decatur Town Board has received many requests for slower speed on the sub-division roads, and the Board feels it is in the best interest and safety of the town and its citizens to regulate the speed on roads where there is a more urban setting:

Section 2: BE IT THEREFORE RESOLVED: that the Decatur Town Board does hereby ordain as follows:

1. STATE TRAFFIC LAWS ADOPTED: Except as otherwise specifically provided in this ordinance, the statutory provisions in Chapters 340 – 350 of the Wisconsin State Statutes, describing and defining regulations with respect to vehicles and traffic are hereby adopted and by reference made a part of this ordinance as if fully set forth herein. Any future amendments, revisions, or modifications of the statutory regulations in Chapters 340 – 350 incorporated herein are intended to be made part of this ordinance in order to secure to the extent legally practicable uniform statewide regulation of vehicle traffic on the highways, streets, and alleys of the State of Wisconsin.
2. SPEED LIMITS ON SUB-DIVISION ROADS The Decatur Town Board does hereby determine that the statutory speed on the following roads are unsafe and imprudent and modifies the speed limit on sub-division roads as listed below:

The following roads at 25 miles per hour:

3. SPEED LIMIT ON GOLF COURSE ROAD The Decatur Town Board further determines that the statutory speed limit on Golf Course Road is unsafe and imprudent and modifies the speed limit on the entire length of Golf Course Road to 35 miles per hour.
4. SPEED LIMIT ON DECATUR/ALBANY ROAD The Decatur Town Board further determines that the statutory speed limit on Decatur/Albany Road is unsafe and imprudent and modifies the speed limit on the entire length of Decatur/Albany Road to 45 miles per hour.
